2. Doha Strike - International Relations

India strongly condemned an Israeli strike in Doha, calling it a violation of Qatar's sovereignty, a significant departure from its past muted responses. This interest-based reaction reflects Qatar's crucial role in India's energy security and diaspora welfare, highlighting the complex balancing act in its West Asia policy.

1. India's Unprecedented Condemnation

The Statement - On September 16, 2025, at the UN Human Rights Council in Geneva, India delivered an unusually strong condemnation of Israel's recent bombing in Doha, Qatar.

Core Message - The strike was termed a "violation of sovereignty" and a significant threat to "regional and global peace, stability, and security."

Significance - This sharp reaction marks a departure from India's typically muted or ambivalent positions on past Israeli military actions in other West Asian countries (like Lebanon, Syria, and Iran), prompting analysis of a potential shift in its foreign policy.

2. The Incident - Israeli Strike in Doha

Date of Attack - September 9, 2025.

Target - A house in Doha where senior Hamas leaders were reportedly meeting to discuss a US-led ceasefire proposal.

Action - The strike was carried out by the Israeli Defence Forces (IDF).

Casualties - The bombing resulted in five deaths.

Israel's Justification - Israel defended its actions by accusing Qatar of "harbouring and funding" Hamas operatives, thereby framing the strike as a legitimate counter-terrorism operation.

3. A Shift in Stance - India's Reactions Compared

India's strong condemnation of the Doha strike contrasts sharply with its previous, more cautious responses to similar incidents, indicating a policy driven by specific national interests rather than a uniform principle.

4. Strategic Drivers Behind India's Strong Stance on the Doha Strike

India's policy was not an abstract shift but a calculated diplomatic move rooted in tangible national interests.

The Critical Importance of Qatar -

Energy Security - Qatar is one of India's largest and most reliable suppliers of Liquefied Natural Gas (LNG), secured through long-term contracts essential for India's energy stability.

Indian Diaspora - Qatar hosts a massive Indian community of over 800,000 workers, who are a key source of foreign remittances. Protecting their welfare is a top priority.

Bilateral Ties - Strong personal rapport exists between Prime Minister Modi and Qatar's Emir, Sheikh Tamim bin Hamad Al Thani, which facilitates high-level cooperation.

Geopolitical Signaling -

Countering the Saudi-Pakistan Pact - The statement was a timely reassurance to Gulf partners of India's solidarity, especially following the signing of a new defense pact between Saudi Arabia and Pakistan.

Aligning with Gulf Concerns - Israel's extraterritorial strike alarmed all Gulf monarchies. By condemning it, India aligned itself with the prevailing regional sentiment, reinforcing its role as a trusted partner.

5. Broader Regional Implications

The Doha strike has sent shockwaves through the region, accelerating geopolitical shifts.

For Gulf Countries - The attack has amplified fears of being caught in the crossfire, leading to urgent discussions within the GCC, Arab League, and OIC about establishing a joint regional defense mechanism.

For Israel - It demonstrates a prioritization of immediate military objectives over long-term diplomatic goals, potentially jeopardizing normalization efforts like the Abraham Accords.

For the US - The incident has further eroded its credibility as the primary security guarantor in the Gulf, creating a strategic vacuum and pushing regional states to seek alternative security partners.

6. Implications for India's West Asia Policy

New Delhi must now navigate a more complex and volatile regional landscape.

Challenges -

The Gaza Dilemma - India's continued silence on the high casualty count in Gaza is creating a perception of bias towards Israel and straining relations with the Arab world.

Maintaining Neutrality - India must work harder to maintain its carefully cultivated image as a neutral actor with ties to all sides.

Opportunities -

Reinforcing Trust - This is an opportunity to strengthen trust and strategic dialogue with key Gulf partners (Qatar, UAE, Saudi Arabia) on energy and security.

Championing Sovereignty - By consistently supporting the principles of sovereignty and territorial integrity, India can bolster its credentials as a responsible global power.
