3. APEC Summit - International Relations

Asia-Pacific leaders wrap up APEC summit after Trump, Xi agreement on trade truce. The APEC Summit (2025) in South Korea concluded with the Gyeongju Declaration, focusing on free trade, digital transformation, and climate action, and saw a thaw in US-China trade relations. India remains a non-member, interested in joining but blocked by APEC's consensus-based rules and geopolitical concerns over its trade policies.

APEC Summit (2025) - Gyeongju, South Korea

Location and Conclusion - The Asia-Pacific Economic Cooperation (APEC) Summit for 2025 was recently held and concluded in Gyeongju, South Korea.

Key Adoptions - The summit concluded with the formal adoption of three significant initiatives -

- 1. The APEC Leaders' Gyeongju Declaration (2025).
- 2. The APEC Artificial Intelligence Initiative.
- 3. The APEC Framework for Cooperation on Population Structure Changes.

Highlights of the APEC Summit (2025)

1. Adoption of Leaders' Declaration (Gyeongju Declaration) - APEC leaders officially endorsed a joint declaration. This declaration reaffirmed the members' collective commitment to four key pillars -

Trade - Maintaining free and open trade and investment across the Asia-Pacific region.

Supply Chains - Strengthening the resilience and connectivity of regional supply chains.

Growth - Actively promoting economic growth that is both inclusive (benefits all members of society) and sustainable (environmentally conscious).

Modernization - Advancing digital transformation and cooperative climate action.

- **2. US-China Engagement -** The summit signaled a notable thaw in bilateral tensions between the United States and China. The leaders of both economies agreed to -
- 1. Resume formal trade dialogue.
- 2. Implement tariff reductions on a selection of goods.

3. Climate and Sustainability Focus

The declaration placed a strong emphasis on environmental goals. Member economies made specific commitments to -

Energy - Accelerate transitions to clean energy sources.

Infrastructure - Support the development and financing of climate-resilient infrastructure.

Cooperation - Enhance cooperation on the development of carbon markets and green financing mechanisms.

4. Digital Trade and Innovation

Member economies emphasized the critical need for progress in the digital sphere. The key areas highlighted for action include -

Standards - Harmonizing digital trade standards to reduce friction.

Data - Promoting secure and efficient cross-border data flows.

SMEs - Supporting small and medium enterprises (SMEs) by improving their access to digital tools and platforms.

About Asia-Pacific Economic Cooperation (APEC)

Founding and Purpose

Establishment - APEC is a regional economic forum that was established in 1989.

Core Mission - Its primary purpose is to strengthen the growing interdependence of economies across the Asia-Pacific region.

Key Operational Philosophies

Nomenclature - APEC deliberately uses the term 'economies' rather than 'countries' or 'nations'. This is to emphasize its focus purely on economic and trade collaboration, thereby avoiding sensitive political or territorial disputes.

Decision-Making - The forum operates through cooperation and consensus.

- 1. It emphasizes voluntary participation and dialogue.
- 2. It does not rely on binding treaties.
- 3. All member economies have an equal voice, and decisions are made collectively.

Member Economies - APEC comprises 21 member economies.

List of Members - Australia; Brunei Darussalam; Canada; Chile; People's Republic of China; Hong Kong, China; Indonesia; Japan; Republic of Korea; Malaysia; Mexico; New Zealand; Papua New Guinea; Peru; The Philippines; The Russian Federation; Chinese Taipei; Thailand; United States of America; and Viet Nam.

Headquarters - The APEC Secretariat and its headquarters are located in Singapore.

Primary Goal - APEC's work focuses on ensuring that goods, services, investments, and people can move easily and efficiently across the borders of its member economies.

Main Objectives

Trade Facilitation - This involves simplifying customs procedures and actively reducing barriers that hinder cross-border movement.

Regulatory Alignment - APEC works to harmonize regulations and standards among its members. This makes the process of exporting and importing more efficient and predictable.

Economic Integration - The forum actively promotes freer trade and investment by fostering a climate of cooperation and innovation.

India's Interest in APEC

Consistent Interest - India has consistently and publicly expressed its strong interest in joining the APEC forum.

Strategic Goal - India views potential membership as a crucial gateway to achieving -

- 1. Enhanced trade with member economies.
- 2. Increased foreign investment.
- 3. Deeper regional cooperation.

Official Efforts - India's Ministry of External Affairs (MEA) has actively pursued this interest. It has hosted discussions and published detailed reports, such as the white paper 'APEC and India - An Appraisal'. These publications emphasize India's potential to make significant contributions to APEC's goals of inclusive and sustainable growth.

Why Isn't India a Member Yet? (Obstacles)

Consensus-Based Decisions - APEC's decision-making model requires unanimous support from all 21 existing members for a new member to be admitted.

Economic Concerns - Some members have historically expressed concerns regarding the pace of India's trade liberalization and the complexities of its regulatory environment.

Geopolitical Balancing - The admission process is complicated by geopolitical factors, especially the ongoing strategic tensions between the US and China, as existing members weigh the implications of India's entry.

Strategic Implications of India's Non-Membership

Limited Influence - By not being a member, India's direct influence in shaping Asia-Pacific trade norms and standards is limited.

Positioning in Other Blocs - This exclusion also affects India's strategic positioning in other major regional blocs, such as the Indo-Pacific Economic Framework (IPEF), where APEC members play a dominant and coordinated role.
